3	Resolution in support of San Francisco's Vision Zero framework to eliminate all
4	traffic-related fatalities in the next ten years through a combination of
5	engineering measures, education, and enforcement.
6	WHEREAS, The Commission on the Environment wants a safe and
7	healthy city where we do everything possible to avoid traffic-related injuries and
8	fatalities; and
9	WHEREAS, Cars and trucks produce greenhouse gas emissions when
10	they burn gasoline or other fossil fuels, which contributes to human-made
11	climate change; and
12	WHEREAS, 40 percent of San Francisco's greenhouse gas emissions in
13	2010 came from cars and trucks, and trips in personal automobiles account for
14	the great majority of these emissions; and,
15	WHEREAS, San Francisco's vulnerabilities to climate change include
16	sea level rise and flooding, heat waves, damage to local ecosystems, and risks
17	to the city's transportation and water infrastructure; and
18	WHEREAS, The City of San Francisco's Climate Action Strategy
19	supports measures that increase walking, transit ridership, ridesharing and
20	bicycling to achieve greenhouse gas reduction goals; and

1	WHEREAS, The City of San Francisco has set the goal for 50 percent of
2	all trips in the city to be made by means other than driving alone in a personal
3	vehicle by 2018; and
4	WHEREAS, According to the San Francisco Department of Public Health
5	(SFDPH), pedestrians and bicyclists are the most vulnerable road users and
6	account for over half of traffic deaths in San Francisco with San Francisco
7	having the highest per capita rate of pedestrian injury of all counties in the state
8	of California; and
9	WHEREAS, According to the SFDPH, at least 800 pedestrians are
10	injured and an average of 100 severely injured or killed and a rising number of
11	bicyclists are injured on San Francisco streets each year; and
12	WHEREAS, According to the SFDPH, pedestrian and bicyclist injuries
13	and deaths are highly concentrated on a subset of city streets, and these
14	streets are disproportionately concentrated in low-income, non-English
15	speaking communities with high densities of seniors, disabled residents, and
16	populations reliant on walking and public transit; and
17	WHEREAS, Measures to make San Francisco's streets safer will
18	encourage people to take trips by walking, bicycling, and multiple modes such
19	as walking to transit; and
20	WHEREAS, The City of San Francisco adopted a Pedestrian Strategy in
21	2013 to reduce serious or fatal pedestrian injuries 25 percent by 2016 and 50
22	percent by 2021; and

1	WHEREAS, Vision Zero provides a framework for reducing traffic deaths
2	to zero by the year 2024 through a combination of engineering, education, and
3	enforcement measures; and
4	WHEREAS, The concept of Vision Zero originated in Sweden, which
5	now has one of the lowest annual rates of road deaths in the world; and
6	WHEREAS, Chicago and New York are among large US cities which
7	have set Vision Zero goals; and
8	WHEREAS, Mayor Ed Lee and the San Francisco Board of Supervisors
9	have endorsed Vision Zero, and San Francisco's Department of Public Health,
10	Municipal Transportation Agency, and Police Department have formally
11	adopted Vision Zero policies to reduce injuries and deaths from preventable
12	traffic collisions; and
13	WHEREAS, The San Francisco Department of the Environment
14	collaborates with other City agencies, including the San Francisco Municipal
15	Transportation Agency and the Department of Public Health, to support policies,
16	programs, and initiatives that promote safer streets such as the Walk First
17	initiative, Traffic Calming Program, Safe Routes to School program, and
18	Pedestrian and Bicycle Strategies; and
19	WHEREAS, The San Francisco Department of the Environment
20	conducts education and outreach to San Francisco residents, commuters, and
21	businesses to increase the number of trips taken by sustainable modes,
22	including walking, bicycling, and taking transit; now, therefore be it
